Nor does the fact that one of the parties has alread vobtained a patent prevent such an interference: or although the Commissioner has no pow-er to cance a patent aiready issued, he may, if he linds that another person was the prior inventor, give him also a patent, and thus place them on an equal isoting before the contract of concert since a limited but impedience
